Summary

- On the 16th of January, payments amounting to 15,288,963 GBP were made to the MNR HSBC GBP account.
- On the 19th of December, payments amounting to 132,608,406 GBP were made to the MNR HSBC GBP account.
- The MNR HSBC GBP account, closed in 2013, was used to receive PSC bonuses from IOCs (including KNOC, Sterling Energy, Heritage Energy and Gulf Keystone).
- On the 24th of December, payments amounting to 5,500,000 USD were made to the MNR HSBC USD account.

What happened to this money?

- Since opening in 2007 until closing in 2013, a total of 212,454,192 GBP was credited to the MNR HSBC GBP account. The breakdown of payments received is as follows:
 - 182,812,725 GBP as PSC bonus income (from various IOCs including KNOC)
 - \circ $\,$ 27,779,487 GBP as sale of stocks and shares $\,$
 - o 1,861,979 GBP as interest
- Since opening in 2007 until closing in 2013, a total of 212,454,192 GBP was debited from the MNR HSBC GBP account. The breakdown of payments made is as follows:
 - 196,245,759 GBP was transferred to the main MNR HSBC USD account (also closed in 2013, following transfer of all funds to Kurdistan International Bank account 1702)
 - o 16,078,357 GBP was used to purchase stocks and shares on behalf of MNR (later sold for 27,779,487 GBP as above)
 - \circ 130,000 GBP was used to fund the Children's Hospital Project
 - 76 GBP as bank charges
